The once Mount Harmon Plantation owner, Sidney George Fisher, an attorney in Philadelphia during the summer months, wrote a daily life in the Earleville area in his Mount Harmon Diaries, 1837-1850. "On May 30, 1837; "Was delighted to get here. Everything is so quiet, so beautiful, so calm, that to such a dear lover of the country as I am, the change from the dusty,

confined & crowded city is most refreshing. It does the mind and heart both good to leave for a time for "bustle of resort." Some sweet "retired solitude" like this, where with nature, books, fresh air and wisdom's "best nurse contemplation" we may forget the petty pursuits of town, ponder our past experience and examine the great mystery of mysteries, our own hearts."
