Smart Meter Project Continues In North East

There are still 130 new water meters left to install in North East, town manager Melissa Cook-MacKenzie told the town board.

One issue with the project is that lids over the meter have to be refitted because they did not line up properly.

The town is working with the software program that will capture the meter readings that will be sent to the town hall.

Town workers are looking at every water account in town. Some have not been closely examined for many years.

With more accurate water meters, town officials said consumers will probably see an increase in their levels of water usage because the old meters were not accurately measuring the water flow.

North East's project on the water lines along Church Street is progressing well, town officials reported. This project is costing close to \$118,000.
