**Chesapeake City Establishes  
A Line Of Credit**

During a special session this week, Chesapeake City's town board agreed to establish a line of credit at Columbia Bank. The line of credit totals \$250,000. This action does not enable the town to spend the money right now. Any expenditures using this line of credit would require a vote by the town Council. One town official explained that when the town has an unexpected expenditure or grant matching opportunity, the line of credit could be used instead of the town having to negotiate a bridge loan.
