The Mayor and Council of the Town of Cecilton upon final reading and motion duly made and seconded, adopted Ordinance #2015-02 at a regularly scheduled meeting on June 8, 2015 to become effective July 1, 2015. Ordinance #2015-02 is an ordinance for the adoption of Fiscal Year 2016 Budgets.

The following summary of tax, water and sewer rates are included in the FY 2016 Budget. The Tax Rate for Real Property will remain at \$0.2195 per \$100.00 assessed value. Water and Sewer usage rates shall change to 2% per quarter to a base (5,000 gallons) of \$132.94 and \$19.86 per unit (1,000 gallons) thereafter.

**North East Ordinance
Is Put On Hold**

Several people came to a recent North East town meeting to question a proposed ordinance that will place tighter regulations on what town residents can keep in their yards.

One town business woman said the ordinance will have the town micro-managing too much of what is on private property.

That sentiment was echoed by town Commissioner Hilary Crothers-Moore who said the ordinance needs more discussion.

"I believe people have the right to have things on their property," Crothers-Moore said.

One woman attending the town meeting said that some people are keeping too much junk in their yards and it is not nice to have that nuisance on a neighboring property.

Mayor Robert McKnight agreed to table the ordinance, known as 2015-05-01, saying that since Commissioner Eric Braley was missing from the meeting, he wanted to wait on the issue until Braley can be there for a discussion.
