the capability to track all deputy vehicles and town police vehicles, allowing them to send the closest officers to a call.

Vehicles operated by the deputies are now filled with the technology to make their job easier.

In-car computers allow them to fill out incident reports. "It's going to save a lot of time," said Chief Deputy Gerald Widdoes, noting that with the need to send incident reports to as many as a half dozen different offices, the computerized system can easily take the information the deputy places into the report and send it wherever it needs to go.

The technology includes the ability to generate E-tickets for traffic offenses with a copy for the motorist, as well as the ability to disperse the traffic citation to the court system.

The computerized system means the deputies are using a computer keyboard instead of the old ticket pad. As

deputies improve their keyboarding skills, this process is much faster than handwriting and while typographical errors are possible, there will be fewer mistakes overall The computer system in the county dispatch center has because handwriting will not be misinterpreted, Sheriff's Office personnel noted.

> Adams said the technology is being rolled out in phases because each update needs time to be installed. Deputies need to be trained in the use of each technology. Then the system needs to be tested and changes have to be made to work out any glitches.

> "There's always some bumps in the road," Sheriff Adams said, explaining that as one technology update begins to work efficiently, they begin to work on another

> While the Sheriff has said he is waiting for amendments to privacy laws and the identification of funding sources before he commits to body cameras for deputies, he is ready to install cameras on department vehicles.

> These cameras will record the view to the front of the

deputy vehicle and the future vehicle cameras as protection for both the public and the deputies.

The actions of police will be verifiable, he said, potentially protecting citizens' rights. If a citizen says deputies are not patrolling a certain area, the Sheriff's Office will be able to pull up the location record of the deputy vehicles to show how many patrols have gone through and area and when deputies went through the area. The cameras will show what has happened as deputies handle incidents in front of their vehicles. Adams said it is a good way to protect both the law enforcement officer and the public.

The driver's seat in a deputy's vehicle looks like a command center. Technology is evident with the computer mounted over the center console.

Vehicles have updated lighting systems that include strong lights on the rooftop light bar, offering deputies a full range of vision if they are looking for someone along a dark road.

Chief Deputy Widdoes said the Sheriff's Office is working toward equipping every patrol car with AED equipment - giving deputies the ability to attempt to reestablish a heartbeat when they come upon a medical

'So far, we have 12 in radar units," Widdoes said.

"We created a standardized police car," explained Corporal Angel Valle, explaining the Sheriff's Office looked at what every vehicle on the road needs to have to be the most effective and they are now working on equipping each vehicle with what is needed.

'We used to have to share radar units and other things,"

This all-inclusive list of what is needed in a law enforcement vehicle also includes the capabilities of the

"All cars are all-wheel drives," Valle said.

"We do have some four-wheel drives," Widdoes added. The function of the vehicle affects which one is ordered. "K9 vehicles certainly need more room," Widdoes said.

The physical characteristics of the deputies are also a factor in assigning vehicles with taller deputies being assigned to the larger vehicles in the fleet. Newer vehicles in the Sheriff's Office fleet have followed the general trend of vehicles offered to the public - they are smaller. Some deputies are requesting that the old standard Ford Crown Victoria models be retained for as long as possible, Sheriff's

The Cecil County Sheriff's Office has 95 vehicles, including some that are used for covert investigations.
