**2015 WATER DISTRIBUTION SYSTEM  
MAINTENANCE PROGRAM**

On Friday October 16th through Saturday October 17th, the Town of Elkton will be conducting semi-annual fire hydrant flushing during the overnight hours from 8:00 p.m. until 4:00 a.m. Periodic fire hydrant flushing is necessary to ensure proper functioning of fire hydrants and to purge the water distribution system of sediment. Water customers may experience some decrease in water pressure, as well as possible degradation of water clarity during or shortly after this maintenance program. Water clarity will be restored subsequent to usage. If you experience water discoloration, run the bathtub spigot until the water runs clear. If you experience brown spotting on white laundry, do not remove the laundry from the machine; visit the Department of Public Works at 209 Blue Ball Avenue or The Elkton Municipal Building at 100 Railroad Avenue - Elkton, Maryland to receive a product that will remove the spots.
