**State's Attorney Says Office
Was Blindsided By \$150,000-
Plus State Mandate**

Cecil County State's Attorney Ellis Rollins came to this week's County Council work session to say he needs \$150,000 - and it is needed quickly. Local officials have been aware that a new state computer system was being rolled-out for the court system. What Rollins said they did not know was that the local jurisdictions would have to figure out what software would work for the state system and would also have to pay for the purchase of the enabling technology and the perpetual annual maintenance of the system.

If Cecil County officials do not fund this project, Cecil County courthouse computers will go blank in mid-July.

The request for funding is \$150,000 plus an additional \$15,000 for operating revenue.

The Council expressed dismay at this need, asking how the State's Attorney could not know about this.

The State's Attorney office said they had an idea the state was not going to fund this in November and have been nailing down the costs during the past couple of months. They said their office informed nearby counties about this cost.
