the material real and teaching him an immense amount about criminal investigations.

Thanks to the externship component of the curriculum, directed by Maryland State Police Capt. Jimmy Russell, Keane was able to get some real-life experience of his own. After learning of Keane's interest to be a trooper, Russell arranged for him to participate in several ride-alongs with the Maryland State Police North East Barrack. Russell also coordinated ride-alongs with the Rising Sun Police Department, Elkton Police Department, Perryville Police Department, and North East Police Department.

"These ride-alongs were the most real part of my education, because I was actually able to apply the concepts learned at Cecil College to events happening in front of me," said Keane.

Documenting the events taking place throughout the course of each ride-along helped condition Keane to have a pen and notepad in his hands just like a trooper does when chronicling the information to fill out a crime report. The experience concluded with using the recorded notes to write a 10-page paper as if he was producing an actual report.
