Schools Will Get LED Lights

The Board of Education has approved a bid for the LED fixtures and energy rebates projects at Rising Sun High School and Perryville High School. MLED Tech, LLC of Columbia, Maryland was selected to purchase and delivery LED lighting fixtures to replace existing school building and parking lot exterior lighting with energy efficient LED lighting. These lighting upgrades will use specific high efficiency outdoor LED lighting fixtures which will qualify for rebates sent back to the school system to offset the cost. The contractor will complete and submit the applications for the rebates and those rebates are expected to total 20% or more of the total purchase price. The rebates were going to be used for future facilities projects in the school system. The Delmarva Power Commercial & Industrial Energy Savings program for Lighting Fixtures and Controls in Existing Buildings is the source of the rebate.

The cost for the purchase and delivery of the lights is \$44,711. The school systems' facilities department will install the LED lights.
