West Cecil Health Center has continued to grow. Ness said they operate a health center in Havre de Grace. More recently, they have opened a second facility in Cecil County. They have taken over the Perryville area health facility operated by the University of Maryland School of Dentistry. The building, located along US40, is still being used to provide dental treatment.

"The University of Maryland is still there working alongside of us," Ness said.

"We hope to expand the services there," he added.

A grand opening of the Perryville area center is set for September 20.

West Cecil Health Center offers primary care, women's health, behavioral health, assistance with eligibility, dentistry and insurance enrollment.

Along with their partners, West Cecil Health has an on-site pharmacy, on-site laboratory, transportation and interpreters, when needed, Ness said.

Their patient numbers and visits increase each year. In 2014, West Cecil Health Center had 4,347 patients with 16,144 visits. In 2016, West Cecil Health Center had 7,395 patients who visited the West Cecil clinics 29,429 times.

To help people of all income levels and types of coverage, West Cecil Health Center has a sliding fee scale.

"The primary thing is that there's no barrier to care," Ness said.
