damages, supervision of the facilities while they are being utilized and details about the usage of the new artificial turf field at Perryville High School.

The agreement does not eliminate the requirement for outside sports groups to pay user fees to help maintain the facility. Each year, the school system takes in approximately \$90,000 in fees from community groups.

County and school officials said the agreement will be up for review every year to address any needed amendments to make the arrangement run more smoothly.

The county handled the \$1 million cost of the Perryville High School turf project and is hoping to add an artificial turf field to other schools every two years until all five high schools in the county have the turf field, which can be used for all outdoor sports.

County Executive McCarthy said this partnership fits in

well with the county's strategic plan which calls for making county residents healthier.

It also makes adding recreational opportunities in the county less expensive for taxpayers.

"This is far more efficient than relying on the creation of new facilities," McCarthy said.

Pointing to the opioid epidemic in the county, McCarthy said that offering many recreational activities for young people is one component of the battle to keep county residents from getting into the drug culture.

Asked about the high cost of putting in the turf field, McCarthy said that Cecil County has a long history of providing very little funding for recreational amenities.

"My opinion is these are Quality of Life issues," McCarthy said.

As for the assumption by some people, including elected officials, that Calvert Park and other recreational facilities would become money-makers for the county, McCarthy
