#### GENERAL WORK DESCRIPTION

The Town of Elkton is seeking a qualified contractor to perform installation of a new 16" HDPE (by directional drill - approximately 115 linear feet) and 12" diameter Ductile Iron Water Main (by open cut - approximately 800 linear feet) including stub connections for future fire hydrants and water service connections along Route 40 between Wilson Avenue and Route 7 in Elkton, Cecil County, Maryland. The hours of operation are: if working at night, lane closure can begin at 8:00 PM and all lanes shall be open no later than 5:00 AM.
